Chiropractic

The CMS-required benefit is limited to coverage for spinal manipulation to treat spinal subluxation. The supplemental benefit offers the full ASH scope of services for musculoskeletal (MSK) spine and extremity conditions. Services include:

- Evaluation and management
- X-ray examination
- Chiropractic manipulative therapy
- Modalities and therapeutic procedures
- Physical rehabilitation



The CMS-required benefit is limited to coverage for acupuncture by ACAOM providers to treat nonspecific chronic low-back pain. The supplemental benefit offers the full ASH scope of services for MSK, pain, and nausea conditions. Services include:

- Evaluation and management
- Acupuncture and acupressure
- Modalities and therapeutic procedures for treatment of pain syndromes, MSK conditions, and nausea.



This service is not a CMS-required benefit. The supplemental benefit offers the full ASH scope of services for MSK and myofascial covered conditions. Services include:

ASH does not administer the CMS-required podiatric benefit. ASH will administer the supplemental routine footcare for nail and skin health management. Services include:

- Removal of corns and calluses

- Preventive maintenance



ASHCare Fall Prevention & Home Safety Assessment Program

The supplemental benefit offers a fall prevention and home safety assessment. Services include:

- A virtual functional assessment with a physical therapist
- A virtual home safety assessment to identify home safety hazards
- An action plan provided by the physical therapist to address risk factors for falling
- An Ankle Weight Kit may be provided to support members in their fall prevention exercise program.*
